



President's Message

Two main purposes of AWL are to promote the welfare, interests and professional development of lawyers who are women and to advance justice for all individuals. The recent article published by *The Atlantic*, "What It Takes to Be a Trial Lawyer If You're Not a Man," highlights why AWL's mission remains as relevant today as it was when AWL was first formed in the 1970s. The article walks through several disadvantages women attorneys face when trying cases before judges and juries. Women litigators are still subjected to intense cultural biases demanding that women act in "traditionally female" ways. Women are expected to stay pleasant for fear of being deemed "emotional." But being friendly can undermine challenging an adverse or hostile witness. It also has the potential of eliminating a woman's ability to be viewed as a "strong" trial attorney in the eyes of juries, judges, colleagues, and clients.

These biases create problems for individual women and their respective careers, which is undoubtedly a significant issue. But more importantly, as the article eloquently explains, "the stakes in the courtroom aren't just a woman's career development and her earning potential. The interests—and, in the criminal context, the liberty—of her client are also on the line." This statement cuts to the heart of why leveling the playing field in the legal profession is imperative. When the fate of a client hinges on his or her attorney's gender (or race or ethnicity), that client is not receiving fair and impartial justice. This isn't just a problem for individual attorneys, it's a problem for the entire legal system.

One way to implement systemic change is to continue to promote diversity in our judiciary. The good news is that the groundwork has been started. There are many men and women focused on adjusting the view from the judiciary to promote more opportunity for groups previously excluded. By opening doors, the "norms" of the courtroom are slowly changing. The norms associated with "femininity" are slowly shifting as participants in the judicial system regularly witness women exerting power and control by presiding over the courtroom. Changing attitudes toward female attorneys is important to the core concept of justice and therefore must be made a priority by us—the lawyers who challenge and uphold the system, not just for ourselves, but for the benefit of all.

With this in mind, AWL is proud to sponsor, along with the American Constitution Society and the *Wisconsin Law Journal*, "Closing the Gavel Gap," a continuing legal education program aimed at educating and inspiring the next generation of diverse individuals to seek a career in the judiciary in order to close the "Gavel Gap." This all-day event will focus on the importance of having a judiciary representative of the people it serves. We look forward to promoting the interests of our members and the public by encouraging diverse candidates to seek positions in the judiciary. And we certainly look forward to seeing you all there on October 19th.

Member Profile: Mary Flanner

Mary Flanner has embraced change throughout her career. Her journey to law school began following a ten-year stint working as an insurance claims analyst. A career in the law offered variety and new challenges, so she enrolled at the University of Wisconsin Law School.

Upon graduation, she honed her skills as a litigator at a big law firm. When her family grew and the hours at the firm become overly burdensome, Flanner decided to leave for a smaller firm that provided a better

work-life balance. "The time commitment was pretty high," she explains. "I was working a lot of Saturdays, and I didn't want to do that anymore." From there, as firms merged and disbanded, she joined firms that allowed her to learn new substantive areas, including estate planning and insurance defense.

When nearing a career transition, Flanner says she relied on her networking to identify possible employers. "I've always looked for a firm that would have individuals that I would feel comfortable working with in terms of a work environment. I enjoy learning new things so changing practice areas was appealing rather than being negative." Flanner's confidence in her litigation skill set and eagerness to learn led her to a new substantive area, employment and whistleblower law, in 2013.

For women anticipating a career transition, Flanner suggests spending time considering "what's important to me, what are my skills, and how would my values and skills fit into the positions I am looking at." Though career change is stressful, Flanner says that flexibility and willingness to make changes help make transitions easier.

Volunteer Lawyers Project

The 2018 Volunteer Lawyers Project (VLP) Fall Training series is just a few weeks away. The VLP offers free CLE-approved training to lawyers who commit to providing pro bono legal services to Legal Action of Wisconsin's low-income clients. The annual series of seminars begins in Madison at the Goodman Community Center on October 18th and 19th. The seminars are "Representing Consumers with Auto Issues" (10/18), and "Representing Clients in Unemployment Compensation Appeals" (10/19).

The training continues in Milwaukee at the UWM School of Continuing Education on October 30th through November 1st, with "Representing Clients in Bankruptcy" (10/30), "Eliminating Barriers to Employment" (10/31); "Nuts & Bolts of Divorce" and "Probate Basics and Real Estate Transfers" (11/1).

The Volunteer Lawyers Project offers this training to recruit and support lawyers who provide pro bono legal services to low income residents of the 39 southernmost counties in Wisconsin. This is an especially important time to get involved in pro bono legal services while the number of people needing assistance increases and funding for legal services providers has been drastically reduced.
